2. **MEDICAL DECLARATION**: Please complete your medical declaration on VHD, Ncovi, Bluezone **BEFORE** checking in to the AGM.
3. **DO NOT** attend the AGM in person should you come from any area subject to isolation and blockade or have any of the signs of fever, cough, shortness of breath, fatigue, etc. In these cases, please authorize to attend the AGM or vote by filling up and sending the Voting Card according to the Company's form to above address **before 5:00 p.m. of June 28, 2021**.
4. **STRICLY COMPLY** with the 5K rule of the Ministry of Health, keep a safe distance of at least 1.5m from others, wear a mask when entering the Building and throughout the process of the AGM.

The list of confirming attendance and medical declaration information will be compiled and reported by the AGM's organizer to the authorities and registered to the Building Management Board as well to ensure the inspection and compliance with prevention and control regulations to all visiting Guests at the Building.

In the situation that Covid-19 pandemic is expanding very seriously in Ho Chi Minh City, in order to strictly implement the regulations of Directive 10/CT-UBND dated June 19, 2021 of Ho Chi Minh City People's Committee, the Building Management Board would reserve the right to refuse entry for those who do not register in the Attendance List or do not comply with the instructions on medical declaration.
